YOU DO HAVE THE AUTHORITY TO MAKE HIM CLEAN UP HIS PROPERTY, AND YET YOU EXPECT ME TO LIVE NEXT DOOR TO THIS MESS FOREVER????????????????? WOULD YOU????????????????? AND YES I SPRAY MY YARD, BUT A LOT OF GOOD IT DOES WHEN THE TRASH NEXT DOOR JUST PILES UP AND IS A BREEDING GROUND FOR THEM. SHAME ON EACH OF YOU!!!!!!!!!!!!!! I AM GOING TO BE 62 YEARS OLD WITH HEALTH PROBLEMS AND NOW MY SON HAS CANCER, HOW MUCH MORE STRESS DO YOU EXPECT ME TO PUT UP WITH. IF YOU GRANT HIM PERMISSION TO PARK ONE MORE VEHICLE EVEN A BICYCLE I WILL SUE THE CITY FOR DERALCTION OF DUTY. I AM DONE BEING IGNORED AND PASSED OFF WHILE YOU ALLOW HIM TO GET AWAY WITH ANYTHING HE WANTS. MY NEXT STOP IS THE MAYOR, PERHAPS HE ISN'T AWARE THAT YOU ALL SHOW UP AND COLLECT A PAYCHECK BUT ACTUALLY DON'T EARN THAT PAYCHECK?? I WOULD LIKE TO ASK HIM!!!!!! I AM SAVING A COPY OF THIS LETTER AND I WILL SEND A COPY TO KILLEEN DAILY HERALD IN THE EVENT THAT YOU ALLOW THIS RIDICULOUS PERMIT TO PASS, ALONG WITH PICTURES I HAVE TAKEN OF HIS FILTHY PROPERTY. YOU SHOULD BE EMBARRASSED TO EVEN ASK IF I WOULD MIND IF HE HAS ANOTHER VEHICLE OF ANY KIND PARKED AT HIS PROPERTY. REALLLYYY?????? YOU'VE GOT TO BE KIDDING???? AND LASTLY, WHY WASN'T THE CITY LETTER SENT TO MY RESIDENCE, WHICH IS NEXT DOOR, WHY WOULD YOU SEND IT TO MY SON'S ADDRESS WHICH ISN'T EVEN CLOSE TO THE PROPERTY IN QUESTION? I WAS HOPING TO ADDRESS THE CITY COUNCIL IN PERSON WITH REGARDS TO THE MATTER ON PARKING VEHICLES ON THE GRASS, BUT DUE TO UNFOREEN CIRCUMSTANCES WITH MY SON'S DIAGNOSIS OF CANCER RECENTLY I WILL PROBABLY BE UNABLE TO ATTEND.

HOWEVER, I DO WANT TO GIVE MY OPINION AND HAVE MY VOICE HEARD ABOUT THE MATTER. I LIVE NEXT DOOR TO A "HOARDER" OF VEHICLES SO I KNOW FIRST HAND TO HAZARDS IT BRINGS.

YOUR VERY OWN ORDINANCES STATE, YOU DO HAVE THE RIGHT TO ENTER ANY PROPERTY TO INSPECT FOR SUCH HAZARDS AND ORDINANCES THAT HAVE BEEN BROKEN. BUT WHEN I GO TO CODE ENFORCEMENT I WAS TOLD THAT ALTHOUGH THE ORDINANCES STATE THAT IT IS ACTUALLY ILLEGAL. THEN WHY WOULD YOU NOT CORRECT THE ORDINANCES TO STATE YOU HAVE "NO" RIGHT TO ENTER ANY PROPERTY FOR INSPECTION? THE ADDRESS NEXT TO ME YOU ARE VERY FAMILIAR WITH AS THIS HAS BEEN AN ONGOING PROBLEM FOR YEARS.....AND YET NOTHING GETS DONE. HE ADDS TO HIS HOARD ANYTIME HE WANTS TO AND DOES SO VERY OFTEN. THE ADDRESS IS [REDACTED] RD,,MR. [REDACTED] IS THE OWNER OF THE PROPERTY. HIS HOARD OF VEHICLES BRINGS DOWN THE PROPERTY VALUE FOR MY HOME AND THAT TOO IS IN THE ORDINANCES THAT GIVES YOU THE RIGHT TO DO SOMETHING ABOUT IT, AND AGAIN NOTHING GETS DONE. I WOULD GLADLY MOVE, BUT WHO WOULD BUY MY PROPERTY AT A FAIR VALUE WITH THE HOARD NEXT DOOR. HE USES THE VEHICLES TO BUILD A WALL AROUND HIS PROPERTY SO YOU CAN'T SEE THE REST OF THE MESS IN THE BACK YARD. IT CAUSES MAJOR PROBLEMS WITH MICE FOR ME AND MOSQUITOES THAT I AM ALLERGIC TO, SO THE HEALTH PROBLEMS WHICH ARE ALSO IN THE ORDINANCES THAT GIVE YOU THE RIGHT TO ENTER THE PROPERTY AND DO SOMETHING SHOULD BE ENOUGH REASON TO HAUL HIS JUNK AWAY. IT'S AN EYESORE, A HEALTH PROBLEM, AND I CAN'T EVEN SEE TO EXIT MY DRIVEWAY SAFELY BECAUSE I CAN'T SEE OVER OR AROUND HIS VEHICLES, THEY ARE PARKED IN THE STREET , ON THE GRASS, THE SIDE OF HOUSE, THE BACKYARD, THE FRONTYARD AND ANYWHERE ELSE HE CAN SQUEEZE ONE IN.

I UNDERSTAND THESE SMALL HOUSES USUALLY HAVE A ONE CAR DRIVEWAY, AND MOST PEOPLE CAN'T AFFORD TO EXTEND THE DRIVEWAY AS I DID, BUT HOW MANY VEHICLES DOES ONE PERSON NEED? LETS BE REASONABLE. IF THERE ARE FOUR PEOPLE WITH A VALID DRIVER LICENSE, THEN EACH PERSON SHOULD BE ALLOWED TO OWN ONE VEHICLE. THEY CAN PARK TWO IN DRIVEWAY WITH ONE BEHIND THE FIRST ONE AND TWO IN THE STREET, BUT WHEN YOU HAVE ONE PERSON LIVING IN THE HOME WITH A VALID DRIVER LICENSE, WHY SHOULD THEY HAVE 30 VEHICLES, INCLUDING MOVING VANS ETC. PARKED ALL OVER THE PROPERTY,,,IN THAT INSTANCE IT DOES CREATE PROBLEMS FOR THE NEIGHBORS.

PLEASE COME AND SEE FOR YOURSELVES WHAT I HAVE TO ENDURE EACH DAY, AND TAKE THAT INTO CONSIDERATION AND COME UP WITH A PLAN TO LIMIT AND FIX THIS NIGHTMARE... PLEASE!!!!!!!
